6. To Presenting Public Awareness initiatives to bolster Human Rights literacy.
7. To focus on encouraging the Govt as a whole to fulfil its Human Rights obligation.
8. To advocating in support of the Democratization and end to corruption.
9. To supporting better Governance and Government Policies.
